Jim Roney was born and raised in Pittsburgh, Pennsylvania. He arrived in Tampa in 1971 and earned a BA in Elementary Education from USF. After working as a paraprofessional in Pinellas County for one year and briefly teaching in Pasco County, Jim began substitute teaching in Hillsborough County.

In 1978, he was the third male hired by Hillsborough County Schools to teach Kindergarten. He worked in the following Hillsborough County Elementary schools: Lutz, DeSoto, Wimauma, Cahoon (for 24 years), Sulphur Springs and Thonotosassa.

He taught Kindergarten (for 22 years), First Grade, Third Grade and was an Elementary Technology Resource Teacher for 7 years. An active member of the Kindergarten Steering Committee, Jim taught numerous trainings as well as oversaw a Kindergarten Professional Study Day.
