From Laura Tucker - Legislative Report

On Tuesday, April 3, 2024 The School Board met to consider the 1 Millage proposal by Superintendent Van Ayres. A Milage is equal to \$1.00 per \$1,000.00 of the taxable value of your home. The plan is to use the majority of the funds for instructional and non instructional pay increases. They have proposed a \$6,000.00 increase for teachers and administration (instructional) and \$3000.00 for non-instructional including bus drivers. Every employee would benefit except for the Superintendent. The School Board voted to approve the referendum to be placed on the ballot so that the citizens of Hillsborough County can decide whether or not to approve the tax. The vote was 6-2 with Hahn and Rendon in the descent.

On Wednesday the Board of County Commission voted to place the Community Investment Tax, a revenue stream that can only be used for Capital outlay, on the ballot in November, a full two years before its expiration date. They passed a motion that would continue to 1/2 cent tax for an additional 15 years. They reduced the amount of the revenue sharing with the school district from 25% to 5%. The Superintendent said that the minimum share needed was 10%. On April 16 there will be another BOCC meeting to approve the final ballot language. There is still time to voice your concerns about this issue.
